

# Bessie D. Brooks Trust Scholarship

---

## History

Bessie Clapp Dunning was born in Bath, Maine on Aug. 18, 1872. She was the only living child of prominent Bath businessman and hotelier Charles Washington “Charlie” Dunning, and his wife Sarah B. Clapp. In 1891 Bessie graduated from the old Bath High School at 864 High Street (the site of the present-day Fire Dept.). This was quite a privilege, since many young people of her day were financially forced to leave school after Grade 8 and earn a living to help support their family.

In 1907 Bessie and her first husband Forrest Nelson moved to Boston for greater opportunity. Forrest died in 1912, and Bessie made her own way for 14 years, until she married Thomas Colby Brooks (who was born and raised in Westport, Maine). Tom had lived in the Boston area since 1888 and had established a successful manufacturing business there. By 1934 Bessie and Tom had moved back to Maine and were living in the Congress Square Hotel in Portland. Tom died in 1934, and Bessie in 1962.

Bessie had no children. After leaving generous bequests to several cousins and friends, her Will stated that she wanted to establish a trust “for the education and support of the boys and girls in whatever line or course such boys and girls seem best fitted...”

For over 30 years, students from Sagadahoc and Lincoln counties have benefitted from Bessie D. Brooks Trust scholarships for their higher education.
